## **BURIAL REQUIREMENTS**

1. Applicant Form duly accomplished
2. Death Certificate with Registry Number Issued by the LCR with Registry No.
3. Proof of relation to the deceased:
  - ° If claimant is the wife – Marriage Contract issued by LCR with Registry No.
  - ° If claimant is a child – Birth Certificated issued by LCR with Registry No.
4. Original Burial Receipts
5. Any valid ID (driver's license/passport)
6. Barangay Certificate

All documents submitted must be either original or authenticated by the office which issued the same.

An application for burial assistance must be filed within two years from date of Veteran's death otherwise it is deemed barred by prescription.
